In Hong Kong, during the EUSA Asia-Pacific Annual Conference, I had the occasion of a long talk to Professor Dai Bingham, one of the founding members of ECSA China and its President. He is professor at the Fudan University in Shanghai, one of the leading centers in European studies. In 1983, after the political changes in China that caused a certain opening in external relations, he was the first scholar from that country working during several months at the European Commission as stagiaire. He worked in the team in which Jacqueline Lastenouse was improving the university action.

One of the most exciting tasks in the last months was this series of interviews to personalities that played a decisive role in the development of European studies. I am grateful also to ECSA for having given to me this opportunity, grateful also for the grant that allowed this project, where the results will remain for the ECSA archives.

Prof. Ruben Zaiotti: New president of ECSA Canada

New chair Prof. Zaiotti succeeds Prof. Frédéric Mérand from Montreal University.

In the 10th of May 2016 Prof. Ruben Zaiotti from Dalhousie University was elected President of the European Community Studies Association-Canada together with the elected Vice-President Prof. Heather MacRae from York University. Prof. Patrick Leblond remains as Secretary-Treasurer.



Prof. Zaiotti is Assistant Professor at the Department of Political Science in Dalhousie University. His main areas of interest are International Relations theory, International Security, border control and European Union politics.

He is currently working on two research projects. The first looks at the transatlantic partnership over issues of homeland security. The second examines the challenges of European Union foreign policy after the signing of the Lisbon Treaty.

Some of their publications are:

- The monograph "Cultures of Border Control: Schengen and the Evolution of European Frontiers" with University of Chicago Press.
- Articles for Review of International Studies, European Security, Journal of European Integration, International Journal of Refugee Law.

Prof. Zaiotti succeeds Prof. Frédéric Mérand, Associate Professor of Political Science at the University of Montreal, Visiting Professor of European Studies at LUISS University in Rome and Deputy Director of the Centre for International Peace and Security Studies.

Prof. Maya Sion assume the ECSA Israel co presidency

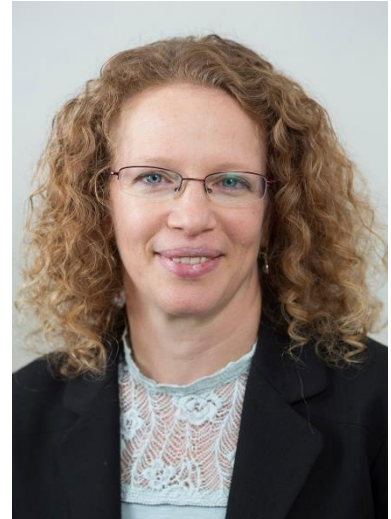
Dr. Sion is Adjunct Professor at the European Studies graduate program of the European Forum at the Hebrew University.

Maya Sion Tzidkiyahu (Jerusalem, 1974) specializes in the European integration process from multi-disciplinary perspectives: historical, theoretical, political, institutional, decision- and policy-making, economic and legal perspectives, as well as EU - Israeli relations.

She has a PhD in European Studies and Political Science (Comparative Politics) in the field of differentiated integration, comparing all case studies of Member States with a formal or informal opt-outs from different European integration policy fields (e.g., EMU, Schengen). She holds a BA in International Relations and MA in Public Policy, Administration and Law.

She is currently also an adjunct professor at the Political Science Department, the International

Relation Department and the Public Policy School at the Hebrew University of Jerusalem, and in the European Studies program at Tel Aviv University.



Prof. Sion will share presidency with Professor Emeritus at the Hebrew University of Jerusalem, Alfred Tovas, founder of ECSA Israel.
